



**NOTES TO NOMINATION FORM**

- ✦ There are 11 positions for election; any personnel can only be nominated for 1 position.
- ✦ All nominees must be SSRA members at time of nomination and is involved in activities that are deemed not to have a conflict of interest with the activities of the association as required by the Charities Act.
- ✦ SSRA constitution stipulates that one of the four members elected shall be a lady ✦ Each nomination must be endorsed by a proposer and a seconder.

The nomination form must be signed by the Proposer and the Seconder who must be SSRA members at time of submission. The form must be deposited at the Singapore Squash Rackets Association (SSRA) office, located at 3 Stadium Drive #01-33 The National Stadium, Sports Hub, Singapore 397630, not later than seven (7) days before the time for holding the meeting, 14<sup>th</sup> September 2021, 7pm. All forms received after that time shall be treated as invalid.
